Ellington used 500 ton of blacktop for skid paving on our roads. Our turn to help the others now. Mowing of roadsides has begun. Grader has been run on Wolcott, Dredge Road and Harris Hollow Roads. Can't grade if there is rain in the forecast. Mutton Road has been seeded on the hillside by County Soil & Water as it is too large of an area to leave bare. The "jointly owned" roller's transmission has broken and had to borrow Town of Poland's. Skateboard equipment has been moved to skate area, barricades and sign need to be placed. Truck #9 back in service from air conditioner repair under warranty.

Supervisor spoke with James Spann of Chaut. County Soil & Water about the gravel bar in the creek. He will meet with Jim Schimek sometime this week about removal.

Property ownership of the driveway to the ball fields was discussed. The attorney will search the property lines and report back to the Town Board.

Attorney has spoken with Councilman Chase about the Employee Handbook. An example of a well contained Handbook is the one from Indian Lake. Need to decide what is needed in the Handbook.

Councilwoman Miles is still working on staining of the sculpture in the Park.

Supervisor discussed "Chautauqua Works" Program that runs from July 1st to June 30th Motion made by Brainard, seconded by Miles to approve Supervisor to sign the contract for this program.

Town Board discussed changes to the Building Permit Application. Building Permit will be valid for one year than need to be renewed if building not completed. Any building construction done without a permit, while in process or completed, should be assessed a fee equal to or greater than original permit.

Motion made by Miles, seconded by Berg to adapt the changes to the current building permit. VOTE: Miles-aye, Brainard-nay, Berg-aye, Cronk-aye Carried.

Councilwoman Miles reported that she received a call that the flags at the cemetery are very worn. We will check with Caretaker and replace with new flags.

Light bulbs in Bandstand are blown out. Will check this out.

Motion made by Berg to adjourn the meeting at 8:35p.m.
